

FACTS	WHAT DOES BEAZER DO WITH YOUR PERSONAL INFORMATION?
Why?	Companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number • Income and account balances • Credit scores if provided by you • Credit card or other debit • Debit card • Checking account information • Wire transfer instructions
How?	All companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons companies can share their customers' personal information; the reasons Beazer chooses to share; and whether you can limit this sharing

Who is providing this notice?	Beazer Homes USA, Inc. and its financial affiliates, including Charity Title Agency, LLC d/b/a Community Title Agency of Arizona in Arizona, Charity Title Group LLC, and Charity Home Insurance Agency LLC
What we do	
How does Beazer protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Beazer collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> • give us your contact information • show your government-issued ID • show your driver's license • give us your income information • provide your mortgage information
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes — information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account—unless you tell us otherwise.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Our affiliates include Charity Title Agency, LLC d/b/a Community Title Agency of Arizona in Arizona, Charity Title Group, LLC, Charity Home Insurance Agency, LLC, and companies with Beazer in their name, such as Beazer Homes USA, Inc., Beazer Homes, LLC., Beazer Home Sales, Inc., Beazer Homes Holdings, LLC, Beazer Homes Texas, LP, Beazer Homes Indiana, LLP and Beazer General Services, Inc.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> • Nonaffiliates we share with can include financial service providers, such as mortgage lenders and insurance agents, and nonfinancial companies, such as title insurance companies.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • We do not jointly market.
Other important information	

For Vermont Residents: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures. For California Residents: We will not share information we collect about you with nonaffiliated third parties, except as permitted by California law, such as to process your transactions, to maintain your account, or with your written consent.
